## QUICK FACTS

New retail light vehicle registrations in Los Angeles County declined $17.1 \%$ during the first ten months of this year versus year earlier. U.S. market fell by an estimated 15\%.

As expected, the market improved in October of this year versus weak year earlier results. October registrations increased 10.9\% compared to 2021.

Registrations increased for Tesla, Genesis, and Ford so far this year.


The graph above provides a clear picture of the trending direction of the county market. It shows the year-over-year percent change in the three month moving average of new retail light vehicle registrations. The three month moving average is less erratic than monthly registrations, which can fluctuate due to such factors as the timing of manufacturer incentive programs, weather and title processing delays by governmental agencies.
