GLANCD A co-hosts Meeting with Governor Jerry Brown



On June 12, 2013, GLANCD A Executive Director, Bob Smith and several GLANCD A Board members hosted a fundraising event with the Governor. The meeting was held in the same building that GLANCD A’s office is located in Downtown Los Angeles.

The event served as an opportunity to sit with the Governor and communicate some of the issues and challenges Automobile Dealers continue to face in Los Angeles, and throughout the state of California. The car dealers’ collective show of support for the administration was evident with current GLANCD A Board members Darryl Holter, Howard Tenenbaum, Howard Keyes, Bert Boeckmann, and Peter Hoffman in attendance.

The meeting started within hours of the governor approving the budget for the State of California. During the meeting local New Car Dealers were able to discuss policy issues. One issue of importance that was discussed is the State Franchise legislation and its impact on New Car Dealers. The meeting also focused on the topic of flat rate pay compensation issues. The flat rate pay compensation is currently in the court system. Meeting attendees expressed their concerns about the flat rate pay to the Governor and the impact on New Car Dealers’ operations.

The strength in numbers that car dealers have in the legislative and regulatory environments, gives credibility and influence in dealing with key elected officials on the local, state, and federal levels. 

The Open Academy, established in 2009, is an emerging arts institution that provides arts program to the youths in our community of Los Angeles. WHAT WE DO...

The Open Academy Youth Orchestra has 3 (three) groups:

Orchestra

As The Open Academy Youth Orchestra's premier performing ensemble, Orchestra students perform in some of Los Angeles' greatest venues. Past and upcoming performances include venues such as the Colburn School's Zipper Hall and USC's Bovard Auditorium. Under the baton of our Conductor, these young musicians work to produce a concert of mature music by renowned composers. Students work with experienced and professional coaches in weekly sectionals to gain masterful technical ability of their instrument.

Chamber

The Chamber musicians are the rising stars! In this performing ensemble, the students develop skills on their specific instrument and gain an understanding of their role in an orchestral setting. With strong leadership from the Open Academy faculty, these young musicians will set high goals to qualify to enter the Orchestra in six months. This group will have their own repertoire to perform as part of the annual concert.

Americana

This is a new program where students will learn non-classical music categorized as Americana – this is music formed by the confluence of the shared and varied traditions that make up the American musical ethos such as folk, country, blues, rhythm and blues, rock and roll. It is music inspired by American culture traditions which is not only represented in classic man made / roots based sounds but also through new and contemporary artists whose music is clearly inspired by these great traditions. This group will have their own repertoire to perform as part of the annual concert.
